- 5) Inscriptions may be done on a piecemeal basis during curling season
- 6) Inscription is guaranteed for the life-span of handles *
- 7) All orders placed by end of season will be completed prior to start of next season
- 8) Special requests or deviations must have prior Executive approval
- 9) Inscription colour and style are at the sole discretion of the Executive
- 10) No refunds or rebates made once inscriptions have been made.

* Life-span is defined as the period of time the current batch of handles are in use. This could be 10, 15 or 20 years. During that time any sponsored handles that break or need replacing, will be replaced with that sponsor's name on it.
